### **NOTICE**

Sub: Recruitment to the post of Jr.Technician at W-1 level at IGM, Hyd.

Initially, a Provisional list vide dated: 14.08.2017 was published on IGMH website stating that the provisionally qualified candidates should be eligible in all respects in the further selection process for appointment. Accordingly on Document Verification 27 candidates out of provisionally declared list could not qualify for want of essential qualification or the candidate failed to report for document verification. **(Attached as Annexure –X)**

2. Later on it was observed that certain aspects have been considered differently while implementing Horizontal & Vertical Reservation including Own Merit candidates. In order to comply the above strictly a merit list of 131 candidates is prepared duly incorporating the provisions contained in Reservation Rules & SPMCIL Recruitment policy-2012. **(Attached as Annexure –A)**

3. For the purpose of transparency and to comply with the provision 15.2 of SPMCIL Recruitment policy 2012 a waiting list has also been prepared and same will remain valid for one year from the date of notification of the final list i.e from 27.02.2019 to 26.02.2020 **(Attached as Annexure –B)**

4. Further, keeping in view the present reduced scale of working at IGM, Hyderabad the competent Authority has decided for distribution of the selected candidates of the select list of IGM, Hyderabad to other Units where vacancies exist or anticipated. Accordingly, the aforesaid candidates have been distributed in the following Units as per the requirement.

5. All the above 131 shortlisted candidates are directed to exercise their options (**Trade wise Option forms – Enclosed**) for desired Units in order of preference. After receiving the options, the posting orders will be issued as per the vacancies stated above. In case options received is more than the No. of vacancies of a specified Unit the posting will be issued in the order of merit and others will be allotted to the Units where vacancies exists as per order of preference mentioned in the option forms by the candidates . However final posting of the candidate would be at the discretion of Management.

7. Out of 131 Candidates shortlisted, 45 candidates (**Attached as Annexure –C**) appointment will be subject to their being found eligible in all respects. These 45 candidates would be required to produce original certificates for verification during **20.03.2019 to 22.03.2019** in support of their claims relating to age, educational qualifications, experience, community, physical disability, medical fitness, possessing good character & Antecedents failing which their candidature will not be considered for Appointment.

8. The India Government Mint, Hyderabad reserves the rights to reject the candidature at any time, if it is found that the candidate does not fulfill the eligibility criteria as per conditions mentioned in the advertisement, medically unfit, not possessing good Character & Antecedents or Suppressed material information.

9. The Selection & Appointment of the aforesaid candidates is subject to the outcome of the writ Petitions pending in the Courts.

10. All the selected candidates would be placed in IDA Pay scales of Rs. 7750-19040 (Pre-revised).
