SIT 2: Earnest Money Deposit :-

i. The required Earnest Money Deposit for the above tendered item(s) is ₹ 20,300.00 (Rupees Twenty Thousand Three Hundred Only) shall be submitted along with tender in Techno-Commercial Bid.

- ii. The EMD shall remain valid for a period of 45 days beyond Bid Validity i.e., 120+45 = 165 days after the date of opening of the tender. - iii. The firm who are registered under **Udyog Aadhar Memorandum (UAM)** as Micro & Small Enterprises (MSEs) for Manufacturing/Selling, National Small Industries Corporation (NSIC), District Industrial Centres (DIC), Small Scale Industries (SSI) for Manufacturing/Selling of Tendered Item may be exempted from submitting the EMD subject to the submission of valid certificate(s) during the tender validity period.
- iv. EMD must be furnished along with the tender in the form of Demand Draft/Fixed Deposit Receipt/Banker's cheque denominated in Indian Rupees drawn on any Scheduled Commercial Bank, in favour of India Government Mint, Hyderabad payable at Hyderabad.

SIT 3: Tender Validity :-

SCC 1: Performance Bond/ Security :-

The supplier shall furnish performance security for an amount equal to 3% of the total value of the contract and valid up to 60 (Sixty) days beyond the date of completion of all contractual obligations by the supplier, within 21 (twenty-one) days after the issue of Notification of Award.

The performance security shall be denominated in Indian Rupees and shall be in one of the following terms:
