- 1. 1. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

2. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

3. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

4. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

4. Experience & Past performance:

Organization/PS U/Public Listed Company. 5. Capability:

The bidder must have capability to provide at least 26 nos. of manpower services continuous in a ny one year before the last date of opening of bid.

6. Financial Standing:

a) The average annual financial turnover of the bidder during the last three years, ending on 3 1.03.2022, should be at least ₹ 90 lakhs as per the annual report (audited balance sheet a

nd profit & loss account) of the relevant period, duly authenticated by a Chartered Accounta nt/ Cost Accountant in India or equivalent in relevant countries.

7. Other Criteria:

- a. Availability of office of service provider: An office of the service provider must be located in the state of consignee & documentary evidence is to be submitted.
- b. The Bidder should be registered / Enlisted Labour Contractor with Labour Department of stat e/central government and copies of valid certificates are to be enclosed.
- c. The firm should have valid registration under EPF, ESI, GST and the copies of certificates should be enclosed with tender document.
- d. The actual deployment will be based on the day to day requirement. The authorities of IGMH shall from time to time notify the requirement subject to the overall requirement of 32 number of Unskilled manpower. The requirement may be reduced as per actual requirement.
- e. The employees engaged by the Contractor should attend the duty in Day and Night Shifts as required by Mint.
- f. The contractor has to pay to its employees not less than the minimum mandatory rates per month in accordance with the Minimum Wages fixed by RLC (Central) Hyderabad/CLC(NEW DE LHI).
- g. The minimum wages as revised by RLC (Hyderabad)/CLC(NEW DELHI) from time to time will be paid by Mint and the same has to be passed to the concerned employees. A record of that should be kept in a register, which may be made available for examination to the Institute/ Go vt. agencies/ authorities as and when demanded.
- h. The Contractor shall be fully responsible for payment of (not less than minimum wages), P.F. contributions, Bonus or any other benefits under various Labour Laws/Acts applicable to him a nd or the personnel employed by him.
- i. The Contractor shall comply with all Labour laws and other laws/statutory regulations applic able to it and/or the personnel to be employed by it but not limited to the Minimum Wages Act, Contract Labour (Regulation and Abolition) Act, Payment of Wages Act, Employees Provident Fund and Miscellaneous Provisions Act, 1952, ESI Act, Payment of Bonus Act etc. from time to time and take such steps as may be deemed necessary in this regard. Further, after repealment of the old laws and effect is given to the new 04 Labour Codes, the same are applicable.

- j. The Contractor shall be fully responsible for making any goods losses, sustained by IGM, Hy derabad by way of theft/burglary, fire damages of any kind to the premises or any other misc hievous deed on the part of its employees.
- k. The personnel of the Contractor shall not enter into any unlawful activity within the IGM, Hyd erabad's premises and shall have good moral character.
- I. The Contractor shall get the antecedent of its personnel verified by the Police and the certificate to that effect should be submitted before their deployment at the IGM, Hyderabad. The PVC Certificates shall be submitted again after a period of 12 months after initial submission. The Contractor shall also submit the names, present and permanent residential addresses and two copies of their passport size photographs to IGM, Hyderabad.
- m. The Contractor shall have his staff examined and medically checked prior to their deployme nt. Any person found medically unfit shall not be deployed.
- n. The working hours of the Mint in the General Shift shall be 09.00 AM to 05.30 PM with half an hour lunch break from 1.00 PM to 01.30 PM. However, the working hours of the labours engag ed will be 8 hours per day with half an hour lunch break. The working hours will be decided by Mint management as per the convenience of factory and may be changed at the discretion of the Mint from time to time. In case of urgency/ emergency, the labour can be deployed beyon d normal duty hours, which shall be compensated through compensatory leave. Working Hours of other shifts are as notified from time to time based on the requirement.
- o. In case of labour disputes for non-payment of minimum wages to the workers or any other di sputes, the payment due to the contractor can be withheld till settlement of the disputes by the Mint or on the orders of the court of law.
- p. The contractor shall have to engage the required number of workers and in case required number is not available on any day, the contract amount will be reduced proportionately, from the monthly payment.
- q. The contractor shall maintain a daily attendance register including the number and names of the workers engaged in the campus/premises for works as per scope of the contract.
- r. The Contractor Shall hold Contract Labour License in the State of Telangana as per the Contract Labour Act. 1970.
- s. Manpower so deployed by the contractor should be in a good physical condition and age sha II be as follows:
 - v DEO's(skilled): 21 to 50 years v Cooks(skilled): 21 to 50 years
 - v Technical manpower(ITI-skilled): 18 to 45 years
 - v Helper & care taker (semi-skilled & unskilled): 21 to 50 years

r. The Manpower supplied have to be in good Physical Condition.

13. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

15. Past Project Experience
