Under MSE Category, only manufacturers for goods and service provider for service are eligible for exemption from EMD. Traders are excluded from the purview of this policy.
- (ii) Purchase preferences to Micro and Small Enterprises and Start-up shall be given to bidders as per the conditions specified in GeM bid subject to submission of valid certificate of registration under UDYAM and Start-up for the tendered services.
- (iii) Purchase preferences to Micro and Small Enterprises and Make in India Product policy (For bids less than 200 Core) shall be given to bidders as per the conditions specified in GeM bid subject to submission of valid certificate of registration under MSME & Make in India and OEM authorization certificate.

In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over Make in India clause.

- (iv) **Liquidated damages clause:** As per penalties non-compliance to GeM General Terms and Conditions of the tender.
- (v) **Payment Terms:** Payment will be made within 30 days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills.
- (vi) Bid-splitting is not applicable.
- (vii) **Delivery Schedule:** 45 days from the date of issue of LOI/PO or NAC
- (viii) The Qualification and eligibility criteria have been indicated as shown below.

#### **Capability-Equipment & Manufacturing Facilities**

The bidder must have an annual capacity to manufacture and supply at least 40 % of the each tendered item. The bidder firm should also submit documentary proof like copy of past purchase order and work performance certificates for supply of the tendered items.

#### **Financial Standing:**

- a) The bidder should not be under liquidation, court receivership or similar proceedings should not be bankrupt. Bidder to upload undertaking to this effect with bid duly printed on their letter head.
- (ix) The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer. The Seller shall, notwithstanding the consent and ass

ignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

- (x) Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:
- a) The Seller fails to comply with any material term of the Contract.
  - b) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
  - c) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
  - d) The Seller becomes bankrupt or goes into liquidation.
  - e) The Seller makes a general assignment for the benefit of creditors.
  - f) A receiver is appointed for any substantial property owned by the Seller.
  - g) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

## **Disclaimer/अस्वीकरण**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in

the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
