- 1. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

Manufacturer Authorization: Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

4. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.

- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

Under MSE Category, only manufacturers for goods and service provider for service are eligible for exemption firm EMD. Traders are excluded from the p urview of this policy.

The bidder must have an annual capacity to manufacture and supply at least 40 % of the each t endered item. The bidder firm should also submit documentary proof like copy of past purchase order and work performance certificates for supply of the tendered items.

Financial Standing:

- a) The bidder should not be under liquidation, court receivership or similar proceedings should no t be bankrupt. Bidder to upload undertaking to this effect with bid duly printed on their letter H ead.

 - f) A receiver is appointed for any substantial property owned by the Seller.
 - g) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has pl aced the Purchase Order on the Seller.
