#### SIT 2: Earnest Money Deposit (EMD) :-

i. The required Earnest Money Deposit for the above tendered item(s) is ₹ 23,000.00 ( Rupees Twenty Three Thousand Only)

- ii. The EMD shall remain valid for a period of 45 days beyond Bid Validity i.e., 120+45 = 165 days after the date of opening of the tender. Any short validity, the tender shall be treated as unresponsive and rejected. The EMD should be in Indian Rupees only. Successful tenderer's EMD will be returned without any interest, after the receipt of Performance Security from the tenderer. Unsuccessful Tenderers EMD will be returned to them without any interest, after expiry of the tender validity period.
- iii. The firm who are registered under **Udyog Aadhar Memorandum (UAM)** as Micro & Small Enterprises (MSEs) for Manufacturing/Selling, National Small Industries Corporation (NSIC), District Industrial Centres (DIC), Small Scale Industries (SSI) for Manufacturing/Selling of **Tendered Item** may be exempted from submitting the EMD subject to the submission of valid certificate(s) during the tender validity period.
- iv. EMD must be furnished along with the tender in the form of Demand Draft/Fixed Deposit Receipt/Banker's cheque denominated in Indian Rupees drawn on any Scheduled Commercial Bank, in favour of India Government Mint, Hyderabad payable at Hyderabad.

#### SIT 3: Tender Validity :-

- i. The tender shall remain valid for a period of 120 days in case of Two-Bid system after the date of tender opening prescribed in the tender document. Any tender valid for a shorter period shall be treated an unresponsive and rejected.
- ii. In exceptional cases, the tenderers may be request by IGM Hyderabad to extend the validity of their tender up to a specified period. #### SCC 1: Performance Bond/ Security :-

The supplier shall furnish performance security for an amount equal to 10% of the total value of the contract and valid up to 60 (Sixty) days beyond the date of completion of all contractual obligations by the supplier, within 21 (twenty-one) days after the issue of Notification of Award.
