NOTICE

The India Government Mint, Hyderabad has conducted an Online Written Examination for 20 posts of Junior Technician(Fitter) at W-1 Level on 13.12.2023. A total of 2822 candidates have registered in response to the above recruitment advertisement out of which 2012 candidates have actually appeared in the online examination held on 13.12.2023.

2. 
