- (ii) **Delivery**: The entire quantity of 5000 Kgs to be converted to equivalent coin blanks within 90 days from the date of issue of GeM Contract as below:
  - a. At least 100 Nos coin blanks should be sent to IGMH for sample approval within 60 days fr om the date of placement of order.
  - b. Balance of 5000 Kgs of coin blanks to be delivered within the next 30 days from the date of conveyance of sample approval by IGMH.
- (iii) IGMH will provide input raw material for conversion of Nickel- Silver coin blanks. However, i n case of full/partial non availability at IGMH the same shall be arranged by the bidder. In su ch cases payment shall be made for the raw material as per monthly average MCX prices pr evailing in the month prior to the date of shipment.
- (iv) If the chemical composition need to be adjusted to meet the required chemistry through th e addition of extra metals. The vendor shall be responsible for submitting the detailed requir ements of the additional metals along with the calculation sheet. The calculation sheet shoul d clearly outline the quantity and properties of the additional metals needed to achieve the desired chemical composition. This information must be provided to IGMH for evaluation and approval prior to implementing any adjustments.
- (v) The raw material to be provided by IGMH shall be either in the form of small blanks, sheet s, small ingots, scissels or scrap. However, the purity of the input raw material given shall be of virgin metal quality (Qualitative analysis using XRF will be provided for the chemical comp osition of material). vi. IGMH representative may accompany the lot and will be present during the process. The cost for the same shall be borne by IGMH. vii. The bidder will provide ap propriate packaging and equipment to safely handle and transport the metal scrap. They will ensure that the scrap is securely packed and loaded onto their vehicles for transportation to their facility.
