#### IV. Acceptance Criteria:

To ensure that the 3D laser engraving machine meets the requirements for coin die manu facturing, the following acceptance criteria shall be considered along with the above speci fication:

- Productivity: The machine should meet or exceed the expected production output, ensuring e fficient coin die manufacturing, two dies of 27mm dia will be engraved to check the consistenc y, and engraving time should be less than 6 hrs for 0.3 mm depth.
- Engraving Precision: The machine should be capable of achieving fine details and sharp edge s on the coin die, meeting or exceeding specified design tolerances.
- Surface Finish: The engraved surface should have a smooth finish, and there should be no vis ible defects or irregularities.
- Material Compatibility: The machine should consistently and effectively engrave hardened Di e Steel (60WCRV7) without causing material damage or distortion.
- Operational Safety: The Class I Enclosure with an optical curtain should provide adequate ope rator safety (Compliant with IEC 60825-1:2014).

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
