- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. - 2. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. B. <u>Technical Specifications for Supply of MDF Wooden Boxes</u>

I.Regular Size and Compact Design Wooden Boxes

Box Dimensions:

- a) Dimensions: The wooden box shall measure precisely
 - a. Regular Size- 106 mm (width) \times 150 mm (length) \times 35 mm (thickne ss), drawing no: CPM /MEDAL/16 may be referred.
 - b. Compact Design 90 mm (width) x 130 mm (length) x 28 mm (thic

- kness), drawing no: CPM /MEDAL/25 may be referred
- c. All the dimensions should be strictly as per the drawing number me ntioned against the wooden box sizes.
- b) Material: Constructed from high quality MDF durable wood.
- c) Finish: The box exterior will feature a PU matte finish, ensuring a smooth te xture and a modern appearance. The exterior surfaces will be highly polished, providing an elegant shine. The interior shall also receive a PU matte finish in the designated color according to the theme.
- d) Color of the box will be customized to match the specific design requirements of the theme, enhancing visual coherence.
- e) Theme details / Gazette will be provided for reference along with the order of boxes.

Top of Box:

a) Designated theme shall accurately depict and Positioned prominently on the top of the box, either a electroplated metal transfer sticker, the composition of the electroplated metal transfer should be in a mix of 95% Nickel, 3% Chrome and 2 % Silver and pasted with Strong adhesion (requirement will be given as per the suitability of theme prior to sample approval/placing order).

Or

Digital UV Printing, Digital UV Transfer Printing with Hard Ink, with raised I nk Effect for a 3D look, Glossy finish.

b) Designing of the theme will be in the scope of the supplier however reference design/images will be provided by IGMH (pdf format). Concurrence shall be obtained from IGMH before productionising the printing.

Hinges: The box shall equipped with Die Cylindrical (Barrel) type Zinc Plated (G olden Colour) crafted from brass metal with size ~5mmX25mm with a superior gold finish, ensuring durability and aesthetic appeal. Shall be fitted appropriat ely giving a lid (top cover) opening angle 90-110°.

Box Inside Details:

- a) Top Lid: The top lid of the box will be lined with soft suede/velvet material, providing a luxurious and protective interior surface.
- b) Bottom Lid: The bottom lid will consist of Eva Foam covered with suede, fea turing a cavity with a diameter of 50.50 mm designed to securely hold a Com memorative Coin encased in a capsule (50mm). A "D cut EVA foam clad" will be strategically positioned along the periphery of the cavity to facilitate easy lifting/removal of the coin capsule. Additionally, a separate label with SPMCIL I ogo and the unit name will be placed at the bottom of the cavity (SPMCIL Logo, and details of unit shall be provided to the Successful bidder), ensuring authen

ticity and brand representation.

- c) Coin Compartments: Dimensions should precisely fit specific commemorative coin.
- d) Coin Protection: The coin will be safeguarded/covered by Eva foam to prevent damage during transportation or handling.
- e) Elastic Band: An elastic band will be incorporated into the top lid to provide a secure compartment for holding a data card, offering additional functionality and convenience.
- f) Safety Pad: A Eva foam safety pad will be provided, featuring one side cove red in velvet cloth, offering enhanced protection and a touch of luxury.
- g) Colors: The colors of the suede, foam clad, and velvet cloth will be carefully selected to align with the overall design scheme of the theme, ensuring visual harmony and aesthetic appeal.

Sleeve / Outer Cover for Box:

- a) Material: Crafted from high-quality 350gsm matte finished imported paper, double folded "C cut" (Opening from right hand side), ensuring durability and a premium appearance
- b) Dimensions: The sleeve dimensions providing a snug fit for the wooden box ensuring it perfectly accommodates the wooden box without being too loose or too tight, without forming vacuum between cover and the Box.
- c) Foiling and Lamination: Silver or gold foiling or UV printed as per the theme design and text matter on the topside area of the sleeve, enhancing visual impact and sophistication.
- d) Alternatively, UV printing may be employed to achieve the desired design e ffects, subject to mutual consent.
- e) Color: The color of the outer sleeve will be tailored to complement the them e design, contributing to a cohesive and captivating presentation. The colour of the outer cover shall maintain the same consistent throughout the production matching with the wooden box colour.

Data Card (Booklet):

- a) Designing of the booklet will be in the supplier's scope. Before productionising, approval of IGMH shall be obtained from IGMH.
- b) Center stappled.
- c) Image to be printed: UV printed logo /image (minimum 3 locations) as per the provided reference drawing/design of the theme
- d) Supplier will ensure that there shall not be any spelling and grammatical mi stakes. In case of any mistakes observed at any time or after receipt of any complaint total booklets has to be replaced without any charge within the stipula ted time (5 days)
- e) Each theme will include a data card booklet consisting of a minimum of 8-1 2 pages, featuring information provided by the Mint. The design of the data card will be meticulously crafted to align with the theme aesthetics.
- f) Printed on high-quality art card paper, ensuring durability and visual clarity.
- g) High Quality, multicolor printing will be utilized to bring the theme design to life, incorporating vibrant hues and intricate details. UV printing at minimum the ree locations on booklet, subject to mutual consent.
- h) The data card will be sized to fit snugly within the designated cavity in the t op lid of the wooden box, ensuring a seamless integration and optimal present ation.

Other requirements:

- a) Packaging: Each wooden box will be securely enclosed within a clear plastic cover with self adhesive packs, providing protection during transit and storage while allowing for easy visibility and handling.
- b) Four magnets (4mm x 2mm) shall be provided on the lid of the box, concealed within the structure for a seamless appearance and secure closure. North and South poles on opposite sides for strong closing force
- c) Strong Gumming: The adhesive used for assembling the sleeve / outer cove r must be strong and long-lasting
- d) Foam Work: Foam covering Material, Velvet cloth from a reputable company, Dust-free, Cutting without thread residue, High-quality finish.

Theme:

- a) Number of Themes: The number of themes will be determined based on the requirements specified by the Buyer for these boxes.
- b) Design Variation: Each theme will feature unique UV design/electroplated lo go and data card, tailored to reflect the distinct characteristics and significance of the theme.
- c) Color Variation: The color of the wooden box will be adjusted to correspond with the specific theme requirements, ensuring cohesion and visual impact.
- d) At any stage from IGMH or costumer complaints, Rejected quantity has to be replaced free of cost. Rejected material has to be lifted within seven days from mint store.
- e) Material shall be rejected if found having any deviations in dimensions, scra tches, poor printing quality, poor wood quality, bends, gumming problems, loo sely fitted magnets and hinges.

Sample Submission:

- a) Before production, a sample must be provided within 10 days after confirming the theme for approval to ensure compliance with specifications and expectations.
- b) Sample approval is mandatory for each new theme.

Acceptance criteria:

- a) Upon receipt of the material, random sampling of around 25 boxes per batc h (batch of 500nos) shall be inspected to ensure compliance with specifications failure to meet the requirements whole lot will be rejected:
- i. Color Matching: The wooden box and outer sleeve must match the specified color accurately.
- ii. Printing Accuracy: The printing on the box, sleeve, and data card must align precisely with the approved artwork.
- iii. Theme Consistency: Each component must reflect the designated theme consistently throughout.
- iv. The coin capsule must be correctly aligned within the cavity and easily i dentifiable.
 - v. Printing must exhibit sharpness, with no smudging or imperfections.
- vi. Adherence to Artwork Specifications: All components must adhere to the approved artwork/Sample specifications without deviation.
- b) Subsequent 100% inspection of the material shall be carried out at later sta ges at the time of packing to maintain quality control standards, any rejection

found shall be communicated to vendor must be promptly replaced to ensure adherence to quality standards and customer satisfaction. Vendor has to replace the same without any extra cost.

All the materials shall be supplied as per the referred drawing as above

- a) Material: The capsule housing the Commemorative Coin shall be construct ed from polycarbonate, ensuring total transparency and optimal protection.
- b) Dimensions: The capsule dimensions shall precisely accommodate the 44. 2 mm diameter coin without any gaps or excessive space.
- c) The capsule must be free from stretches, dust, and any abnormalities that may affect the clarity or protection of the enclosed coin.
 - d) C cut shall be provided on the top lid for easy opening.
- e) Acceptance criteria: Upon receipt of the material, random sampling of arou nd 25 capsules per batch (batch of 5000nos) shall be inspected to ensure com pliance with specifications, failure to meet the requirements; whole lot will be r ejected and has to be replaced.
