B. Scope of work:

a) The non-Comprehensive Annual Maintenance Contract shall consist of checking and testing of all the CC TV surveillance system's accessories installed in Mint premises which shall be covered by this contract. Pr eventive maintenance will be carried out six times in a year (i.e. bi-monthly) & vendor has to submit the re port at end of each preventive maintenance.

b) The Annual Maintenance Contract shall also comprise of deputation of 01 regular full time skilled Engine er with 01 year documented experience during the office hours (all working days) for uninterrupted workin g of Components of CCTV Surveillance system covered under this contract. Engineer should be technically qualified and well experienced to attend the repairs, operation & maintenance and troubleshooting of the s ystem.

c) The wiring/cabling work of the CCTV Surveillance system, whether underground or over ground also com es under scope of work.

d) Viewing facility provided in CGM Office as well as DC (CISF), including the viewing screen and componen ts like CPU along with the cabling work will be covered under the scope of this contract. 05 nos Workstatio ns provided in CCTV Control Room will also be covered in this contract, along with large viewing screens.

e) VMS will also be covered under the contract.

C. Roles and Responsibilities:

The roles and responsibilities of the Engineer are as follows:

a. Regular monitoring of 78 nos CCTV Surveillance system and any active active/passive components asso ciated with them, including the Network as well as Storage infrastructure.

b. Trouble shooting/diagnosing of 78 nos CCTV Cameras.

c. Regular/whenever necessary cleaning/ maintenance/ relocation/re-routing of 78 nos CCTV Surveillance

system Cameras covered by this contract.

d. Regular monitoring and maintenance of CCTV network infrastructure which shall be covered under this c ontract.

e. Regular resolution of issues related to CCTV Control room including software/ hardware which are given under the scope of this contract.

f. Engineer should assess requirement of spares and consumables if required and inform in advance to IG MH to avoid delays in maintenance of the system.

g. It is reiterated that the firm shall deploy only those person/persons in the Premises of IGM, Hyderabad, who have been cleared by means of a Police Verification Report (PVR).

h. Firm has to submit Police Verification Certificate (PVC) of the resident engineer. The Engineer shall carry his Identity Card/ Gatepass with him at all times while he remains in the premises of IGM, Hyderabad.

i. The firm has to submit qualification and experience details of the Engineer in advance, any change of en gineer during service should be intimated to IGMH in advance.

j. The execution of the AMC should be by the company itself.

k. Vendor is responsible to take care of the system, so that the system does not lead to major breakdown a nd in case the system goes into fault, it should be rectified within the shortest stipulated period.

I. Vendor has to support, maintain & monitor the application software & have to assure that 90 days stora ge of data/Video footage is present in the system.

11. Buyer Added Bid Specific SLA

Text Clause(s)

I. Service Level Agreement:

a) Upkeep and maintenance of 78 nos CCTV Surveillance system cameras and any active/passive compone nts associated with them, including the Network as well as Storage infrastructure will be the responsibility of the vendor.

b) Engineer has to report to IGMH Official on daily basis & need to submit the report by the evening. Any c omplaints against the Engineer or deficiency in services by him will attract penalty and if required he shoul d be replaced immediately. He will be bound to follow the Security and Safety norms of IGMH. In case the s aid Engineer is absent, the firm will deploy a replacement for the said Engineer. Failure to do so will attract penalty as per provisions of NPM.

c) Penalty Clause may be applied as follows:

If the down time for any camera exceeds 24 hours, and reason for the same is due to the vendor's faliure in rectifying the same, penal recovery shall be made from the payments due to the contractor at the following rates: • 1-7 days excluding date of lodging of complaint: Rs. 100/- per day per camera • From 8th day t

o 30 days: Rs. 250/- per day per camera • More than 30 days: Rs. 350/- per day per camera.

d) Apart from the Preventive Maintenance service, in case of a service call is made by the Mint, the compa ny shall depute its technician/engineer to inspect the system, the same should not be considered as one of the six scheduled visits as per the AMC contract. First response time on complaint 2 working hours; Resolu tion time 48 working hours & can be extended on mutual consent with valid reasons for effect on cause. N o additional charges shall be payable for these visits.

e) If required, the Service provider shall repair the parts (covered under AMC) of the system in the premise s of the IGM, Hyderabad itself. No part shall be allowed to leave the premises of IGM, Hyderabad.

II. PAYMENT TERMS:

- Payment for NCAMC of CCTV Surveillance system will be made on monthly basis o n receipt of invoice, subject to satisfactory delivery of services and its certification b y Officials of IGM, Hyderabad.
- Payment for OTDR testing & Splicing will be done on actual execution of work basis

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत का समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
