- 1. Steel work in built up tubular (round, square or rectangular hollow tubes etc.) trusses etc., including cutti ng, hoisting, fixing in position and applying a priming coat of approved steel primer, including welding and bolted with special shaped washers etc. complete.
- 2. Providing and fixing pre-coated galvanised iron profile sheets(size, shape and pitch of corrugation as appr oved by Engineer-in-charge) 0.50 mm (+ 0.05 %) total coated thickness with zinc coating 120 grams per s qm as per IS: 277, in 240 mpa steel grade, 5-7 microns epoxy primer on both side of the sheet and polyest er top coat 15-18 microns. Sheet should have protective guard film of 25 microns in minimum to avoid scr atches during transportation and should be supplied in single length upto 12 metre or as desired by Engin eer in-charge. - 12. Providing and fixing factory-made solid Wood Polymer Composite (WPC) single extruded Door Frame sect ion of 100\*65 MM with encapsulation of 6 MM rigid layer on all external surfaces. The door frame will have a rebate of 32MM/ 37 MM. The two Vertical members are to be joined together with the horizontal member using 8x75 MM long MS Star full thread screws to be used with reverse forward speed control hand drilling machine. The ready/assembled door frame is fixed to wall using Z Hand fast 300 MM long hold fast.
- 13. Supplying and fixing of Unplasticized Poly Vinyl Chloride (UPVC) 2 Track-2 Panel Sliding windows with me sh duly manufactured using UPVC reinforced profiles of 91 mm x 49 mm x 2.20 mm for outer frames, 62 m m x 41 mm x 2.20 mm for sliding shutter frames capable of mounting single glazing system, structurally r einforced with 30 mm 15 mm x 1.5 mm with hot dip galvanized up to 50 microns of minimum thickness of 1.0/1.2 mm and the shutter of fly screen with fibre mesh shall be made of size 21mm x 58mm extruded uP VC window profile section of white colour having outer wall thickness of 2.2mm (± 0.3mm) provided with r einforcement of minimum 1.5mm thick G/J/U/S/O type GI section duly mitred cut and thermal welded at all corners and prefabricated & welded through fusion welding. The window sash shall be fitted with 5 mm thi ck clear float glass of reputed make & Glazing bead shall be co-extruded with Grey colour soft PVC. Syste m shall have single point locking with Touch Lock and the system is to be installed at the site using anchor fasteners, silicon rubber sealant, easy glazing/ deglazing at site etc., including cost and conveyance of all materials, accessories, labour charges for transportation, erection at site complete for finished item of wor k.

Providing, supplying & fixing of Top hung Ventilator With Exhaust Fan Provision made from multi chamber ed uPVC sections with TPV Gasket for sash & Glazing bead shall be co-extruded with Grey colour soft PVC and reinforced with Galvanized Iron profiles throughout the window. - 2. Masking/floor covers are to be used for covering the floor/machine/equipment while doing painting operat ions i.e., to avoid the paint stains to avoid stains on the floor/machine/equipment.
- 3. The firm/contractor has to make own arrangements for getting tools, ladders, equipment, machinery, sca ffolding, personal safety items and etc. towards scope mentioned above at all heights of building structure s in IGMH.
- 4. Firm's belongings i.e. tools/machines/balance materials/equipments/scaffolding/ladders/ safety items and etc. are to be taken back with proper permission letter/ gate pass within two months from the date of com pletion of the contract work in IGMH.
- 5. The firm has to remove/clean the paint stains from the floor if required.
- 6. If any waste debris generated while doing in painting operation the same has to be collected and lifted fro m the IGMH premises to outside of the Mint with contractor's own arrangements.

- 7. It is the responsibility of the contractor to provide necessary/ required PPE to the deputed working labour/ staff. Under any circumstances IGMH will not be responsible for the accidents if any.
- 8. The firm may be asked to quote the rate on service item wise as mentioned above.
- 9. **Site Visit:** Bidders are advised to visit the work site before submission of bid, to know the exa ct nature of works/details of work locations etc.
- 10. **Payment Terms:** Payment will be made within 30 days after completion of contract and based on the ac tual execution and handing over same by vendor to IGMH.

#### 11. ELIGIBILITY CRITERIA:

a. For MSE/Startup firm: Capability-Equipment & Manufacturing Facilities: The bidder firm should have capability to manufacture and supply of tendered items.

b. For other firm- Experience and Past Performance: The bidder firm may be manufacturer/proven sup plier/authorized dealer or distributer of tendered item or bidder may participate with manufacturing author ization form(issued by manufacturer of tendered item)

c. The bidder should submit the signed and stamped copy of tender document as a token of acceptanc e of all the terms & conditions of the tender.

d. The bidder should submit the acceptance of tender specifications .
