1. II. <u>TECHNICAL SPECIFICATIONS:</u>

1. General Specifications:

- a) The complete plant shall be liable of refining of silver with input purity $\ge 20\%$ to output purity ≥ 99 . 5%.
- b) The plant shall be consisting of two reactor units with capacity to process 300 Kg of impure silver in each reactor i.e. total 300 + 300 = 600 Kg.
- c) The complete plant must be able to process 600 Kg of input silver alloys. Output quantity will be pro portionate to the input purity i.e. fine weight of silver present in the silver alloy.
- d) The plant must be equipped with Zero Emission Scrubbing System for arresting toxic fumes like NOx
- e) The minimum processing capacity will be 50Kg of impure silver alloys in each Reactor.
- f) Electrical specifications: 440V 50 Hz three phase AC.

2. Reactor Units:

- a) The reactor units must be made of Stainless Steel (SS 316) of suitable thickness (min 4 mm).
- b) Each reactor must have the capacity of processing of 300 Kg of input silver alloys.
- c) The reactors must be equipped with proper air & chemical inlet lines and a suitable drainage facility with suitable valves.
- d) Each reactor must be equipped with suitable acid resistant agitator or stirring mechanism as per cap acity.

3. Acid Storage Tanks:

- a) The tanks must be made up of Stainless Steel (SS 316) of suitable thickness (min 4 mm).
- b) The tanks must have the capacity of min. 700 litres.
- c) The tanks must be equipped with proper chemical inlet lines and a suitable drainage facility with sui table valve.

7. Hydraulic Auto Press Machine:

8. Settling Tanks:

9. Chiller Unit:

- a) The unit must have freezing capacity of min. 700 litres and water capacity of min. 300 litres.
- b) The chiller must be equipped with a Stainless Steel circulation pump of min. 1 HP.

10. Copper Recovery Unit:

- a) The unit must be made of SS 316 of suitable thickness (minimum 4 mm)
- b) The unit must be consisting SS Tumbler of capacity 1500 litres with suitable charging and liquid drai nage points.
- c) The unit must be equipped with rotation hydraulic gear box of capacity 5 7 ton with operating switc h with tumbler rotation solid wheel attachment.
- d) Copper recovery unit processing capacity of min. 200 Kg at a time.

11. Effluent Treatment Plant (ETP):

- a) Complete Effluent Treatment Plant must be capable of processing minimum 5000 litres or more.

- c) The settling tanks must be equipped with suitable drainage valves and suitable capacity sludge tray s for collection sludge.

- d) The ETP must be consisting of suitable Hydraulic filter press machine of sufficient capacity for proce ssing 5000 litres of treated effluent solution at a time.
- e) The final disposal of processed effluent must be drained through suitable filtration unit consisting of softener filter, carbon filter, sludge filter and filtration pumps etc.

12. Fume Neutralization / Scrubbing Unit:

a) At-least 2 stage, suitable capacity fume neutralization units must be there for complete absorption o f toxic fumes e.g. NOx. And zero toxic fumes emission as per environmental compliances.

13. Control Panel System:

- a) The plant must be completely controllable with the control panel system showing the vital process p arameters.
- b) The plant must be consisting of Auto Dosing facility for chemical (acids) dosing.

III. <u>TRAINING:</u>

The supplier shall impart necessary training to the persons belonging to the Purchaser's organization fo r minimum 5 working days at IGMH site in the disciplines of:

- a) Programming and operation 6 persons
- b) Electrical and electronic maintenance 2 persons
- c) Fluidics and Mechanical maintenance 2 persons

IV. ERECTION & COMMISSIONING:

The Supplier shall arrange for the erection, commissioning and successful demonstration for functioning of the plant with full utilities plant and accessories.

V. <u>DELIVERY SCHEDULE:</u>

The delivery period for supply, installation, commissioning and Final Acceptance Test (FAT) is 60 days fr om the date of issue of Contract.

VI. FINAL ACCEPTANCE TEST (FAT):

- a) The Final Acceptance Test must be conducted at IGMH site after successful installation and commiss ioning of the complete plant with all the utilities and accessories for 3 days.
- b) The plant shall be checked at its maximum capacity of input silver i.e 600 Kg of purity of ≥20%. Silv er alloy will be provided by IGMH.
- c) The plant should be running without any failures or plant/machine breakdown for the 3 days period.
- d) During the FAT the total output of the plant must be calculated based on the input purity of the silver alloys i.e. in terms of the fine weight of the silver in silver alloys.
- e) The effective process loss for the complete process must not exceed 1.0 % in terms of Fine Contents of silver. For any loss more than 1.0% in terms of fine contents during the FAT, the plant will be rejec ted.
