- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order

quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

Detailed Scope of Work pertaining to Overhauling and Testing of 11 No's 11KV and 05 No's 33KV VCB's of IGMH Substation:

- A. Overhauling scope of work of each VCB:
- i. Cleaning of complete breaker with CRC-226
- ii. Removal of old grease and re-greasing the same with recommended grease & Lubrication of all moving parts of mechanism. Oiling of closing & tripping coils.
- iii. Checking of gear box operation.
- iv. Check condition of arcing contact and gap between fixed and moving arcing contacts and correct if required.
- v. Checking of contact arm assembly and complete cleaning of contact surface.
- vi. Checking the reset mechanism, tripping of breaker through push button and correct if required.
- vii. Checking tripping of VCB through protection release.
- viii. Reconditioning and refurbishment of interconnection joints, if required.
 - ix. Checking presence and proper tightening of hardware and correct if required.
 - x. Checking of all circlips , lock washers of VCB.
 - xi. Checking of Damping Gap (Should Not Be Zero.) and correct if required.
- xii. Checking of Vacuum interrupter.
- xiii. Checking of Test/Service Aux. Switch Operation.
- xiv. Checking condition and alignment of jaw contact with cradle terminals
- xv. Checking condition of VCB wiring and report if any abnormality in wiring.
- xvi. Checking and adjusting gap between hylam sheet and side plate and correct if required.

- kvii. Checking spring charging limit switch operation and correcting if required.
- viii. Checking of front drive key operation both in test position and service position.
- xix. Checking condition of arc chutes and correcting if required.
- xx. Checking VCB tripping through shunt release.
- xxi. Checking motor operation.
- xxii. Checking of closing coil and Tripping Coil operation.
- kxiii. Checking the healthiness of CTs.
- xiv. After the inspection, the VCB shall be checked for proper termination and correct if required.
- xxv. Checking of breaker's proper on/off operation manually & electrically.
 - B. Testing of VCB and submission of reports of following tests for each VCB

B-I) Routine Tests

- Contact Resistance test
- ii. Insulation resistance test
- iii. Measurement of Roller gap.

B-II)Type Tests:-

- i. Short circuit test
- ii. Mechanical endurance test
 - C. Spare parts required for the VCB's if any found defective during the above works to be reported & a list of spares required to be suggested to enable us to maintain the same as spares for future use.
 - D. Terms and Conditions:
- i. The spare parts/ accessories if any required for replacement will be provided by IGMH and any consum ables, connecting wires, required tools and testing equipment shall be in the scope of Vendor.
- ii. Vendor should mandatorily have not less than 33KV license to execute similar kind of maintenance work s on VCB's
 - iii. Warranty of services: Post completion of service, right from the date of issue of Service completion/satisfaction certificate by IGMH, if any issue observes with serviced VCB, vendor has to provide service support at free of cost to all the Breakers as and when required up to a period of 1 year.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- A. Eligibility Criteria:
- i. I. Vendor should mandatorily have not less than 33KV license to execute similar kind of maintenance works on VCB's.

b. Payment Terms: Payment shall be made within 30 days after successfully completion of tendered services and a pproval by Mint authorities and submission of bills to IGMH.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Generic

Manufacturer Authorization: Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
