

- a) Note 1: Candidates at S. No: 2 & 5 shall be appointed as Junior Office Assistant at B-3 Level only after acquiring minimum educational qualification as per the Recruitment Policy of SPMCIL i.e. Graduation with at least 55% marks and Computer knowledge subject to passing typing speed on computer in English @40WPM/ in Hindi @30WPM from Government Institute, within 5 years as per recruitment rules amended from time to time, failing which the compassionate appointment shall be terminated.
- b) Note 2: Candidates at S. No. 1,3,4,6,7 and 8 shall be appointed as Junior Technician at W-1 Level only after acquiring minimum educational qualification as per the Recruitment Policy of SPMCIL i.e. Full time ITI Certificate in relevant trade recognized by NCVT/SCVT as per SPMCIL Recruitment Policy, within 5 years as per recruitment rules amended from time to time failing which the compassionate appointment shall be terminated.
