- I. Repairing of Factory Ground Level Reservoir as per the drawing No. CPM/MAINT(C)/67/A dated 09.02.2021. The detailed scope of work is given below.
- II. Total area quantity: 925 Sq.m (9,953 Square ft.).

Scope of work:

- i. Cleaning of GLR completely i.e. internal floors, side walls, ceilings and external walls and entire over roof slab for assessing the leakage crack points and damage portions at floors and side walls.
- ii. HMWS & SB or Bore well water has to be filled up to required level in factory GLR and assess the leakage points in all the side walls.
