# **Technical Specifications:**

- I. General Specifications:
- a. The complete plant shall be liable of refining of silver with input purity  $\geq$  20% to output purity  $\geq$  99.5%.
- b. The plant shall be consisting of one reactor unit with capacity to pr ocess 300 Kg of impure silver and another one of same capacity of 3 00 Kg of impure silver will remain as stand by.
- c. The feed shape and size of the input impure silver alloys are rectangular ingots of 2-3 Kg weight and granules of 5-10 mm thickness.
- d. The complete plant must be able to process 300 Kg of input silver a lloys at a time. Output quantity will be proportionate to the input purity i.e. fine weight of silver present in the silver alloy. The reactor of same capacity will be kept as standby.
- e. The plant must be equipped with Zero Emission Scrubbing System for arresting toxic fumes like NOx form both the reactors.

- f. The minimum processing capacity will be 50Kg of impure silver allo ys in the reactors including the spare one.
- g. Electrical specifications: 440V 50 Hz three phase AC.

#### **II. Reactor Units:**

- a. The two reactor units must be made up of Stainless Steel (SS 316) of suitable thickness (min 4 mm).
- b. Each reactor must have the capacity of processing of 300 Kg of input silver alloys separately.
- c. The reactors must be equipped with proper air & chemical inlet lines and a suitable drainage facility with suitable valves.
- d. Each reactor must be equipped with suitable acid resistant agitato r or stirring mechanism as per capacity.

# **III. Acid Storage Tanks:**

- a. The tanks must be made up of Stainless Steel (SS 316) of suitable t hickness (min 4 mm).
- b. The tanks must have the capacity of min. 700 litres.
- c. The tanks must be equipped with proper chemical inlet lines and a suitable drainage facility with suitable valve.

# **IV. Precipitation units:**

- a. The tanks must be made of Stainless Steel (SS 316) of suitable thic kness (min 4 mm).
- b. The tanks must have the capacity of processing min 200 Kg of fine silver.
- c. The tanks must be equipped with proper tilting gear box with stan d and structure and stirring assembly.
- d. Minimum volume required 800 litres or as designed for processing 200Kg. of Silver at a time.

#### V. Filtration Unit for liquids:

- a. The movable filtration unit must be equipped with proper filtration tray with nets or suitable mechanism as designed.

- c. Filtration Unit capacity must be min. 300 litres.

# **VII. Hydraulic Auto Press Machine:**

- a. The machine must be made up of SS 316.
- b. Suitable for pressing minimum 10Kg pure silver powder to make a l ump at a time for ready to melting,
- c. Lump Diameter must be max. 5 inches,
- d. The load capacity of the pressing machine must be min. 28 ton.

# **VIII. Settling Tanks:**

- a. The tanks must be made up of PP-FRP (Polypropylene with Fiber R einforced Plastic) of capacity min 5000 Litres.
- b. The tanks must be equipped with proper inlets /drainage system w ith valve and bubbling system.

### IX. Chiller Unit:

- a. The unit must have freezing capacity of min. 700 litres and water c apacity of min. 300 litres.

# X. Copper Recovery Unit:

## **XI. Effluent Treatment Plant (ETP):**

- a. Complete Effluent Treatment Plant must be capable of processing minimum 5000 litres or more.
- b. The ETP must be equipped with 1 reactor tank of suitable capacity and 2 nos. of settling tanks of suitable capacity for processing 5000 litres at a time.
- c. The settling tanks must be equipped with suitable drainage valves and suitable capacity sludge trays for collection sludge.

- d. The ETP must be consisting of suitable Hydraulic filter press machine of sufficient capacity for processing 5000 litres of treated effluent solution at a time.

- b. The plant must be consisting of Auto Dosing facility for chemical (a cids) dosing.

#### **XIV. TRAINING:**

The supplier shall impart necessary training to the persons belonging to the Purchaser's organization for minimum 5 working days at IGMH s ite in the disciplines of :-

- i. Programming and operation 6 persons
- ii. Electrical and electronic maintenance 2 persons
- **Fluidics and Mechanical maintenance 2 persons**

## XV. ERECTION AND COMMISSIONING:

The Supplier shall arrange for the erection, commissioning and success ful demonstration for functioning of the plant with full utilities plant a nd accessories.

#### XVI. PRE-DISPATCH INSPECTION (PDI):

Supplier shall arrange for a Pre-Dispatch Inspection / DEMO of installat ion sequences for capacity verification of each accessory at the supplier's factory site for maximum 3 officials of IGMH for 2 days. The expenses towards travelling, boarding & lodging will be borne by IGM H. All the scope of specifications of the complete refining plants along with utilities shall be inspected during the PDI.

## **XVII. FINAL ACCEPTANCE TEST (FAT):**

- a. The Final Acceptance Test must be conducted at IGMH site after su ccessful installation and commissioning of the complete plant with a II the utilities and accessories for 3 days.
- b. The plant should be running without any failures/ breakdown of pla nt/machine for the 3 days period of FAT.
- c. Each reactor of the plant shall be checked at its maximum capacity

d. The output purity of the refined silver must be ≥ 999.0 PPT during the FAT. - e. The effective process loss for the complete process must not excee d 1.0 % in terms of Fine Contents of silver. For any loss more than 1 .0% in terms of fine contents during the FAT, the plant will be reject ed.
- f. During FAT trial all chemicals and consumables will be supplied by the firm at free of cost.
