- i. The actual deployment will be based on the day to day requirement. The authorities of IGMH shall from time to time notify the requirement subject to the overall requirement of 74 numbers of manpower. The requirement may be reduced as per actual requirement.

The PVC Certificates shall be submitted again after a period of 12 months after initial submission. The Contractor shall also submit the names, present and permanent residential addresses and two copies of their passport size photographs to IGM, Hyderabad.
- x. The Contractor shall have his staff examined and medically checked prior to their deployment. Any person found medically unfit shall not be deployed.
- xi. The working hours of the Mint in the General Shift shall be 09.00 AM to 05.30 PM with half an hour lunch break from 1.00 PM to 01.30 PM. However, the working hours of the labours engaged will be 8 hours per day with half an hour lunch break. The working hours will be decided by Mint management as per the convenience of factory and may be changed at the discretion of the Mint from time to time. In case of urgency/ emergency, the labour can be deployed beyond normal duty hours, which shall be compensated through compensatory leave. Working Hours of other shifts are as notified from time to time based on the requirement.
- xii. In case of labour disputes for non-payment of minimum wages to the workers or any other disputes, the payment due to the contractor can be withheld till settlement of the disputes by the Mint or on the orders of the court of law.
- xiii. The contractor shall have to engage the required number of workers and in case required number is not available on any day, the contract amount will be reduced proportionately, from the monthly payment.
- xiv. The contractor shall maintain a daily attendance register including the number and names of the workers engaged in the campus/premises for works as per scope of the contract.

- xv. The Contractor Shall hold Contract Labour License in the State of Telangana as per the Contract Labour Act, 1970.
- xvi. The Manpower Supplied have to be in good physical condition and age shall be as follows:
- v DEO's(skilled) – 21-50 years
 - v Cooks(skilled) – 21 to 50 yaers
 - v Technical Manpower(ITI skilled) – 18 to 45 years
 - v Housekeeping & sanitation(unskilled) – 21 to 50 years
- xvii. ESIC is not applicable for skilled category manpower. Bidder must provide Medical Insurance facility to the skilled category outsourced employee and their authorized family members. Optional allowances 1 indicate the same.
- Xviii. For the unskilled category manpower, ESIC is applicable as their basic wages falls within the wages limit of ₹ 21,000.00 as prescribed by ESIC eligibility policy.

6. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

7. Buyer Added Bid Specific ATC
