Text Clause(s)

1. HIRING OF 23 SEATER BUS (WITH FUEL AND WITH DRIVER):

- i. The vehicle shall be manufactured on or after 01.01.2022 and run for not more than 75,000 Kms
- ii. All the Compliances as specified in the Motor Vehicles Act & Rules Made thereunder shall be complied.
- iii. The Contractor should invariably ensure availability of Fuel, lubricants etc., for running of the vehicle properly.
- iv. The Contractor should ensure the vehicle is in Good Condition with frequent servicing as mandated after completion of prescribed kilometres. Whenever, the vehicle is sent for servicing alternate vehicle may be provided.
- v. The Maximum Number of Kilometres per month are 2000 kms with 24x7 hrs service.
- vi. The rates indicated per month are inclusive of all operational expenses for the operation of Vehicle and n o other claim for other expenses are admissible. These include Statutory levies, cost of fuel, oil, Maintenan ce, insurance and other incidental charges.
