9. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

A. Scope of Work for CAMC for Operation and Maintenance of 50 KLD capacities MBBR based STP

1. The Motors, pumps, spare parts, oil & grease, glands, spanners, maintenance tools tackles etc. Raw materials like chemicals etc. consumables necessarily required for day to day operation & maintenance of 50KLD capacity MBBR (Moving Bed Bio Reactor) based STP shall be arranged by bidders.
2. **The agency / contractor shall provide 2 Skilled Manpower for smooth operation and Maintenance works of 50 KLD capacities MBBR based STP. Qualified professionals experience in STP works of minimum 2years Experience shall be deputed on shift basis daily for Monday to Saturday excluding Sunday & Holidays and also during all working day of the Month (If any Sunday & Holidays).**
3. In case of additional labour required for necessary work if any shall have to be arranged by firm.
4. Preparation & Dosing Chemical Solutions of required concentration and quantity.
5. General cleaning and house-keeping (Cleaning of drain, channel, MS grating in STP etc.to ensure the cleanliness in and around water works area including, jungle and general cleaning.)
6. Operation of all electrical & mechanical machinery including electrical panels.
7. Clean / Preventive / minor the air filters on Air Blowers regularly. Change all air Filters periodically.
8. Preventive/minor maintenance of pumps, blowers, Motors and Other equipment's.
9. All chamber, all screen bars (manual & auto) and all tank cleaning
10. Bidder has to follow plant safety rules, security rules, and labour contract Act etc.as applicable and amended time to time.
11. Bidders have to ensure treatment compliance as per TSPCB/CPCB discharge norms by smooth operation of all wastewater treatment facilities such as STP.
12. Bidder /contractor has to operate all kinds of pumps, motors, compressor, filtration unit and other process equipment including maintain them in good working condition installed in the STP.
13. Bidder/ contractor has to operate filtration plant for uninterrupted supply of treated water for gardening of GMH Plant and Township, including back wash of filtration plant.
14. Operator has to write & maintain the plant operation & maintenance of logbook on daily basis in shifts if required.
15. Operation of filtration plant for ensuring smooth supply of treated water for irrigation/gardening purpose.
16. STP operators have to do all works and given report day to day in charge time to time.
17. The cost of consumables & spares will be borne by the agency only, Consumables materials like test lamp, bolts, dusters, liveries etc required for operation & maintenance,
18. PPE for safety of workmen engaged shall have to be provided by Bidder/contractor.
19. Maintain necessary records, return, manifestation system, log book or other statutory records as directed by Regulatory body for compliance of Rules & Regulation relating to conservation & protection of Environment.
20. Periodical visit on monthly basis by the Environmental Engineer.
21. The CAMC service contract shall be for a period of 12 (Twelve) Months

B. General Conditions

1. Bidder /contractor taken STP Inlet and Outlet water samples from Mint and carry out the analysis report for Standard parameters as per the TSPCB CFO rules i.e. pH, Total Suspended Solids -TSS, Dissolved Solids, Oil & Grease, Chlorides, Sulphates, Bio Chemical Oxygen Demand- BOD & Chemical Oxygen Demand- COD
2. Analysis report has to be submitted monthly once.
3. It is strongly advised for prospective bidders to visit the site of work to get a thorough understanding of the scope of work involved. No request for clarification on tender scope shall be entertained after opening of bids.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
