


Section VII: SCOPE OF WORK & SPECIFICATIONS:

- Cleaning of chocked sewer line by diesel running vehicle mounting hydraulic operated high pressure suction cum jetting sewer cleaning machine fitted with pump having 4000 litres suction capacity and 6000 litres water jetting tank capacity.
- 2. Deployment of skilled operator, supervising engineer etc. for cleaning and partial de-silting of manholes.
- 3. De-chocking and flushing of sewer line from one manhole to another by high pressure jetting system of 2200 PSI for sewer line from 150mm diameter upto 300mm.
- 4. Manually cleaning of manholes by going inside the manhole completely.
- 5. Lifting of sedimented sand/accumulated silt at appropriate location in the manholes.
- 6. Safety measures while cleaning inside the manhole and sewer lines are in scope of contractor only.

A. General terms and conditions:

- 1. The firm/contractor has to make own arrangements for getting tools, ladders, equipment, machinery, scaffolding, personal safety items and etc. towards scope mentioned above.
- If any waste debris generated while doing the works mentioned in scope, the same has to be collected and lifted from the IGMH premises to outside of the Mint with contractor's own arrangements.
- 3. It is the responsibility of the contractor to provide necessary/ required PPE to the deputed working labour/staff. Under any circumstances IGMH will not be responsible for the accidents if any.
- 4. Firm may visit the site before quoting, to understand the actual scope of work.
- 5. Firm has to follow all safety and security guidelines.
- 6. The above quantities may vary depending upon actual requirement of IGMH.
- 7. Firm should take utmost precautions while working at the proposed site in view of electric cables/connection in the site.


