If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder

seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.

3. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.

4. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.

5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

#### **Subject: NCAMC (Non - Comprehensive Annual Maintenance Contract) of G+3 Manual Door Passenger Lift for a period of 12 months**

##### **A. Scope of NCAMC Service for G+3 Manual Door Elevator includes**

- i. Lubricating moving parts and hinges: Apply appropriate lubrication to all moving parts such as pulleys, bearings, and hinges etc., to reduce friction and maintain smooth operation.
- ii. Checking lift operation and responsiveness: Verify that the lift is responding promptly, doors are opening and closing smoothly, and there are no abnormal sounds or vibrations during operation.
- iii. Verifying proper functioning of buttons and indicators: Test all buttons, floor indicators, and emergency

buttons to ensure they are functioning correctly.

- iv. Inspecting and cleaning door mechanisms: Check the door opening and closing mechanisms, including rollers, tracks, and sensors, for any obstructions, damage, or misalignment. Clean them to remove dust or debris that may affect proper functioning. Check fixing of door operator cams, micro hitches and other mechanical parts.
- v. Inspecting and cleaning the hoist way and pit area: Thoroughly inspect the hoist way and pit area for debris, oil leaks, or any signs of damage. Clean the area to maintain a safe and clean environment.
- vi. Testing and adjusting door closing and leveling: Check the door closing speed and leveling accuracy to ensure they are functioning properly. Make necessary adjustments to maintain proper door operation and alignment. Inspect and check for proper floor alignment.
- vii. Checking and cleaning elevator shaft lighting: Inspect and clean the lighting fixtures in the lift shaft to ensure adequate illumination for maintenance and emergency situations.
- viii. Check the chain or belt tightness and wear.
- ix. Inspecting and testing safety features: Check the emergency brakes, over speed governors, and other safety devices to ensure they are functioning correctly. Test their operation as per the manufacturer's guidelines.
- x. Testing and recalibrating elevator sensors and switches: Test the door sensors, limit switches, and other sensors to ensure accurate detection and smooth operation. Recalibrate if necessary.
- xi. Inspecting and adjusting door locks and latches: Check the door locks and latches for proper engagement and alignment. Adjust or replace any faulty components as needed.
- xii. Comprehensive inspection of all mechanical and electrical components — Conduct a thorough inspection of the lift's mechanical and electrical systems, including motor, cables, brakes, control panels, and wiring. Identify any signs of wear, damage, or potential issues that require attention. Checking of contactors, relays, connectors & fixing of wirings.
- xiii. Inspect and check the cab and frame rail.
- xiv. Clean the elevator pit and exterior elevator cab.

**B. Terms and Conditions:**

- i. Mandatory monthly preventive maintenance visits during AMC period ['Visit' - means engineer/technician's preventive maintenance visit at our site to complete all the mentioned scope of works.]

ii. Unlimited Lift breakdown call visits.

iv. iii. All basic consumables such as Oil, Grease, cleaning cloth, Insulation tapes etc., as required for Service of the lift will be in the scope of Vendor.

### 3. Buyer Added Bid Specific ATC

1. The bidder should have capability and capacity to provide the similar services.

### 4. Buyer Added Bid Specific SLA

Text Clause(s)

i. This NCAMC is for a period of 12 Months from the date of issue of contract.

ii. Successful vendor should ensure to complete all service jobs as mentioned scope of works during their Preventive maintenance visits and should maintain corresponding checklist of mentioned jobs, certified by Section in-charge of Electrical maintenance section and same should be submitted along with bill.

iii. The Non- comprehensive maintenance charges shall be payable to the Successful bidder on Monthly basis after submission of invoice along with Service/ Maintenance call reports.

iv. Any additional spare parts /accessories as required for replacement should be provided by IGMH.

v. In case of unsatisfactory services provide by NCAMC service provider, issued contract can be terminated at any time during the term of contract with an advance notice of 15 days.

vi. payment Terms: The Non- comprehensive maintenance charges shall be payable to the Successful bidder on Monthly basis after submission of invoice along with Service/ Maintenance call reports

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.**
