- c) Fluidics and Mechanical maintenance 2 persons
  - 12) Erection & Commissioning:

The Supplier shall arrange for the erection, commissioning and successful demonstration f or functioning of the plant with full utilities plant and accessories.

13) Pre-Dispatch Inspection:

Supplier shall arrange a Pre-Dispatch Inspection at the supplier's factory site for officials of IGMH for 1 day. The expenses towards travelling, boarding & lodging will be borne by IGMH. All the scope of specifications of the complete refining plants along with utilities shall be inspected during the PDI.

For PDI for one day - the following parameters will be checked -
