 - i. **Evaluation Method**: The Total Price quoted should be strictly as per price schedule uploa ded in the tender for item shall be considered for evaluation & to decide L-1 bidder.
 - **ii. Raw Material**: The raw material required for making 30,000 pieces of Silver blanks is to be lifted by the vendor from India Govt. Mint, Hyderabad in the form of "999 Silver ingots, hav ing approximately weight of 20 kg each" or "999 Silver in any other form like scissel or odd size bars etc."
 - **Packing**: Packing to be done for individual blanks basis to avoid any scratch during transit. The blanks should be packed in such a manner that they are not exposed to open atmosph ere during the transportation.
