Heavy Duty 12"×6" Rolling Mill

The supplier is required to design, supply, install & commission Heavy Duty 12"×6" Rolling Mill fulfilling following technical specifications.

I. Material Processing & Performance Specifications

- i. Materials to be Processed: The Rolling mill is to be designed for the cold rolling of Pure Gold and its alloys, Pure Silver and its alloys, a specific Quaternary Alloy (Ag 50%, Cu 40%, Ni 5%, Zn 5%), and Cu-Ni (75%-25%).
- ii. Input Material Profile: It shall process rectangular, flat bars.
- iii. Input Material Dimensions: Width: 25 to 75 mm; Length: 300 to 450 mm; Maximum Thickness: 15 mm.

iv. Output Specifications:

- Ø Final Thickness: The Rolling mill must achieve an output thickness of up to 0.6 mm.
- Ø Thickness Tolerance: The achievable tolerance on the final thickness is +/- 0.010 mm.
- Ø Machine Speed: The rolling speed should be variable, ranging from 1 to 15 meters per minute.

- v. Working Direction: The mill should be reversible, meaning it can roll material in both forward and reverse directions.

II. Work Roll & Mechanical Specifications

- i. Roll Dimensions: The rollers should have a size of 305 mm (L) x 152 mm (D)
- ii. Roll Material: The work rolls must be made from high-grade forged steel, specifically D2, DIN 1.2327, or 86CrMoV7. Test certificate of material composition and NDT has to be provided.
- iii. Roll Hardness: The required hardness for the rolls is 62-67 HRC (NABL test certificate has to be provided).
- iv. Roll Accuracy & Finish:
 - Ø Round Running Accuracy: Must be within +/- 1 Micron.
 - Ø Surface Finish Accuracy: Must have a surface roughness of $Ra \leq 0.50 \mu m$.
 - Ø Roller Mouth Openness: The maximum opening between the rollers is 20 mm.
 - Ø Roll Gap Adjustment: Features a manual screw-down system for precise adjustment of the roll gap to control material thickness.
- v. Feeding System: Equipped with in-feed and exit tables that have adjustable steel roller guides for strip feeding. The guides have flared entrances for easy material entry.

III. Drive, Electrical & Control Specifications

- i. Motor and Drive System: The mill is driven by a powerful 10 HP electric motor with a speed of approximately 1000 RPM, coupled with a heavy-duty gear system. The motor should preferably be of Crompton make.
- ii. Power Supply: Requires a three-phase power supply.
- iii. Operational Controls: Includes standard controls such as start/stop buttons and speed control knobs.
- iv. Technology Standard: All electrical devices are required to be energy-efficient and of the latest proven technology, not nearing obsolescence.

IV. Lubrication System

- i. System Type: The mill must have an integrated automatic lubrication system to ensure consistent lubrication of parts.
- ii. Lubricant Application: One supplier specified that the gearbox uses oil lubrication, while the bearings use grease lubrication.

V. Safety & Environmental Specifications

- i. Emergency Stop: Must have an easily accessible emergency stop button or lever for immediate shutdown.
- ii. Safety Guards: Equipped with protective guards and enclosures to prevent operator contact with moving parts.
- iii. Overload Protection: An overload protection system is integrated to prevent damage to the mill from excessive loads.
- iv. Regulatory Compliance: All safety devices must be provided as per IS (Indian Standard) regulations.
- v. Acoustic Noise Protection: The machine must be designed to keep operational noise levels below 75 dB.

VI. Required Deliverables & Certifications

- i. Roller Sets & Bronze Bushings: Total Two Roller Sets (including one set with machine, including bearing and chocks, ready to install condition) and one set of Bronze bushings must be provided.
- ii. Material Test Certificates: The supplier must provide test certificates for the material composition and Non-Destructive Testing (NDT) of the work rolls.
- iii. NABL Certified Reports: Test certificates from NABL (or an equivalent international standard) are mandatory for Roll Hardness, Surface Roughness, and Chemical Composition.
- iv. Accuracy of measurement for the rollers: Dimensional measurement reports for key components, including the work rolls and their round running accuracy.

VII. Scope of Work:

- i. The scope of this procurement encompasses the design, manufacturing, supply, installation, testing, and commissioning of one (1) new Heavy Duty 12"x6" Rolling Mill as per the detailed technical specifications. The successful bidder's responsibilities shall include the following:
- ii. Supply of Equipment: To provide one Heavy Duty 12"x6" Rolling Mill, complete with all necessary auxiliaries and accessories required for its operation. This includes one set of rollers with bearings and chocks ins

talled on the machine, an additional set of rollers ready for installation, and one set of bronze bushings.

- iii. Civil Works: To provide detailed foundation and machine layout drawings, including specifications for electrical, air, oil, and water trenches. The scope of supply includes all civil work necessary for the machine's foundation.
- iv. Installation and Commissioning: To perform the complete installation, testing, and commissioning of the machine at the India Government Mint, Hyderabad (IGMH) worksite. This includes a successful trial run to ensure the equipment meets all specified performance parameters.
- v. On-site Training: To provide on-site training to IGMH employees for three working days (eight hours per shift) following the successful commissioning of the machine.
- vi. Documentation: To supply three hard copies and one soft copy of the comprehensive Operating and Maintenance manuals in English. This documentation must include a spare parts catalogue and all relevant drawings.
- vii. Testing and Certification: Facilitate a Pre-dispatch Inspection at the seller's premises, providing necessary in-house testing facilities free of cost.
- viii. Conduct a Final Acceptance Test (FAT) at the IGMH site for two working days, demonstrating a minimum output of 20 kg per shift and verifying all functional, quality, operational, and safety interlock checks.
- ix. Provide NABL or International Standard test certificates for the hardness, surface roughness, and chemical composition of the rolls. Additionally, provide certificates for roller accuracy and a dimensional measurement report for key components like the work rolls.
- x. Long-Term Support: To provide a formal undertaking to offer sales and service support, including the supply of spares and consumables, for a minimum of ten years from the date of the Final Acceptance Certificate (FAC). The bidder must also provide a priced list of spares and consumables required for five years of operation.
- xi. Warranty: To supply all services and spare parts free of cost during the warranty period.

VIII. Purchaser's (IGMH) Responsibilities:

- i. IGMH will provide the necessary supply of electricity and water for the machine's operation.
- ii. During commissioning, IGMH will provide access to tools such as gas cutting equipment, welding machines, hand grinders, drills, and material handling equipment (e.g., EOT Crane, Forklift), as well as two helpers.
- iii. The buyer will bear the fees for any nominated external inspection agency and external laboratory testing charges required during the pre-dispatch inspection.

IX. Warranty and service support:

- i. **Warranty Period:** The equipment must be covered by a warranty for 12 months from the date of supply or installation. During this period, the successful bidder is required to supply all necessary services and spare parts free of cost.
- ii. **Long-Term Service Support:** The bidder must provide sales and service support, which includes the supply of spares and consumables, for a minimum period of 10 years from the date of the Final Acceptance Certificate (FAC). A formal undertaking to this effect is required from the bidder.
- iii. **Spare Parts and Consumables:** The bidder is required to provide a priced list of spares and consumables necessary for five years of operation from the date of the FAC. However, the rates quoted for these spares will not be considered when determining the lowest bidder (L1).

X. Delivery Schedule: The Rolling Mill is required to be supplied, installed, testing, commissioning within six months from the date of issue of GeM contract.

XI. Pre-Dispatch Inspection (PDI): Before the machine is dispatched, the buyer has the right to conduct an inspection at the seller's premises to ensure it complies with the contract specifications. The seller must notify the buyer when the goods are ready for this inspection. The goods will only be dispatched after they have been cleared in the PDI.

XII. Spare Parts and Consumables: Bidder shall provide list of spares and consumables required for Five (5) years from the date of Final Acceptance Certificate (FAC) in their technical bid (without price). Quote the rates for these spares separately in financial breakup column (or upload the pdf form with the price breakup). These rates for spares will not be considered while deciding L1. Also, the bidder should only quote the total cost for manufacturing, supply, installation of the tendered machine/goods in total cost column on GeM price bid.

Eligibility Criteria

- i. **For MSE/Start-up Firm: capability-Equipment & Manufacturing Facilities:** The bidder firm should have capability to manufacture and supply of tendered item.
- ii. **For other firm: Experience and past performance:** The bidder firm may be Manufacturer/proven supplier/Authorized dealer or distributor of tendered item or bidder may participate with manufacturing authorization form (issued by manufacturer of tendered item).
- iii. The bidder should submit the acceptance of technical specification of the tender.
- iv. The bidder should submit stamped & signed copy of tender document as a token of acceptance of all the terms & conditions of the tender.

15. Warranty

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
