Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 8. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. - iii. Supplier must submit Test Certificates from any NABL accredited laboratory or Manufacturer in support of the composition details of the chemical.
- iv. Supplier must submit Material Safety Data Sheets (MSDS) along with the supply of the mater ials.

II. <u>ELIGIBILITY CRITERIA</u>

- i. For MSE/Start-up Firm: capability: The bidder should have capability to manufacture and su pply of tendered item.
- ii. For other firm: Experience and past performance: The bidder firm may be Manufacturer/pro ven supplier/Authorized dealer or distributor of tendered item or bidder may participate with m anufacturing authorization form (issued by manufacturer of tendered item).
- iii. The bidder should submit the acceptance of technical specification of the tender.
- iv. The bidder should submit stamped & signed copy of tender document as a token of accepta nce of all the terms & conditions of the tender.
- III. Delivery Period: Half of the total quantity to be supplied within 30 days from the date of placement of contract. Rest half quantity must be supplied after 120 days but befor e 150 days from the date of issue of contract.
