1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
3. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover shall upload the supporting documents to prove his eligibility for Relaxation.
5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
7. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

**1. Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

## 2. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

### **SCOPE OF SERVICE FOR AMC OF RITTAL PANEL AIR CONDITIONERS:**

#### **I. Servicing of Panel cooling units (Panel AC's and HMI Unit AC's): 25'Nos.**

- i. Four Preventive Maintenance visits per year
- ii. Thorough inspection and cleaning of compressor, condenser and evaporator
- iii. Chemical cleaning of condenser coils
- iv. Measurement of evaporator and condenser temperatures
- v. Checking running ampere consumption of compressor
- vi. Inspection and rectification of PCB and electrical connections
- vii. Checking cooling effect and if it is found that gas is less the same will be topped up (required refrigerant gas has to be provided by the IGMH)
- viii. 24x7 technical support
- ix. Immediate response for breakdown calls
- x. Checking/ tightening of all the screws/ fasteners
- xi. Checking and tightening of electrical contact points and parts
- xii. Checking all the electrical parts and wiring
- xiii. Checking cooling effect and if it is found that gas is less the same will be topped up.

#### **II. Overall servicing of 25 No's Panel ACs and HMI unit AC's including cleaning and preventive/predictive/breakdown maintenance activities on cooling unit i.e. PANEL ACs and HMI unit AC. Submission of List of wounded components/spares needs to replace to be given if any part failure observes during overall servicing works.**

Broad service works to be performed (if applicable) include:

- i. Checking the thermostat: Calibrate and level the thermostat and test it for proper operation.
- ii. Checking & tightening the electrical connections: Inspect and tighten electrical wiring and connections. Test and inspect contactors for burned pitted contacts. Inspect and test capacitor s if available. Check Relays. Check On/Off Circuit Breaker Safety
- iii. Lubricating the moving parts.
- iv. Inspect the bearings for wear and lubricate as needed.
- v. Inspect condenser coil.
- vi. Inspect Evaporator Coil Condition and Brush Evaporator Coil if required.
- vii. Monitor operating pressures of the refrigerant.
- viii. Monitor and measure amperage and volt draw of the compressor
- ix. Checking and clearing condensate drain line if available.
- x. Checking the system controls.
- xi. Cleaning the filters/filter assembly.
- xii. Measuring the amperage and voltage of the blower motor for proper operation.
- xiii. Measure Temperature at Supply Grill
- xiv. Measure Temperature at Return Grill
- xv. Measure Temperature Differential

Submit the report of measured values as mentioned above along with bill.

#### **III. Refilling of Refrigerant Gas in 25 No's Cooling Units (Panel AC' s and HMI Unit AC's):**

Gas refilling service will be needed per unit basis hence payment will only be made at actuals on per unit refilling basis during servicing activity if Gas refilling requirement arises in Panel AC/ HMI Unit AC.

- i. Provision of Refilling gas will be under the scope of IGMH
- ii. Checking pressure of Refrigerant Gas
- iii. Topping with maximum limits if observe low gas
- iv. If Observe any type of leakages during this stage, Gas leakage arrest and nitrogen flushin

g along with leak check and accordingly refrigerant gas refilling should be done.

- v. Suitable type refrigerant gas according to the make and model of the Panel AC and HMI Unit will only be used during refilling time.

### 3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

#### **ELIGIBILITY CRITERIA:**

-

1. The bidder firm should meet following eligibility criteria to qualify:

(a) For MSE/Start-up firm: The bidder must have capability to provide the relevant services.

(b) For other firm - Experience and past performance: The bidder should have experience of having successfully supplied relevant services of atleast 10 nos. of similar Rittal Panel, in any one of the last five years ending on '31.03.2026'.

(c) The bidder should submit signed & stamped copy of bid document as a token of acceptance of all the terms & condition of the tender such as Scope of Work, Payment Terms etc.

(d) Payment Terms: Payment will be made on Quarterly basis on submission of invoice after due certification.

### **अस्वीकरण/Disclaimer**

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export

experience.

9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.**
