The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover shall upload the supporting documents to prove his eligibility for Relaxation.
5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
6. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### 1. Generic

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

## 2. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

### **A. Detailed Scope of Services under Non-comprehensive AMC of 625KV A (Caterpillar)& 55KVA(Kirloskar) DG Sets includes:**

- i. Thorough inspection of engine lubricating system, water circulatory system, air intake system, lube oil pressure.
- ii. Cleaning the engine with a dry clean cloth. Checking the engine oil level, top up/ replacement if required. Ensure no Oil/Fuel/Water leakages in the engine and No Exhaust leakages.
- iii. Check for leaks if any and shall be rectified.
- iv. Checking and servicing of engine for smooth running, its unusual sound and color of smoke and exhaust and set it right in case of deviations.
- v. Cleaning of air filter assembly. The air filters shall be cleaned periodically with compressed air, check batteries and top up the distilled water if required.
- vi. Checking the total electrical circuit of the engine. Checking proper functioning of the meters and selector switches, sensors and safety controls.
- vii. Checking charging alternator output voltage with respect to specifications. Diagnosis of faults in engine and Alternator and its rectification.
- viii. Draining the fuel filter bowls to remove sediments and water if required.
- ix. Checking the condition of the battery for sulphation, tightness of connections. Cleaning of battery terminals and applying petroleum jelly.
- x. Checking of Battery specific gravity every month and the acid level once in three months and top up with distilled water if required. Output voltage check and condition check to be carried out. Also includes De-Sulphating & greasing of battery.
- xi. Checking of self-starter and charging alternator for proper functioning.
- xii. Check functioning of charging alternator, fan belt tension. Maintaining the deflection within 8-10 mm at the center. (in case of electric start)
- xiii. Check fan and alternator drive belts and tightened if required.
- xiv. Checking and tightening of all external fasteners, all hose connections and all lube & fuel connections. Checking the condition of All Hoses and Clamps
- xv. Checking of all engine parameters and ensuring trouble free performance. To carry out condition monitoring of DG set engine for proper working.
- xvi. Checking of self-starter and charging alternator for proper functioning.
- xvii. Checking for proper condition of vacuum Indicator.
- xviii. Checking of throttle control and its setting.
- xix. Checking of coolant concentration and top up if required.
- xx. Checking, repairing and attending leakage of fuel, lubricating oil and coolant. Top-up/refill of the same whenever required.
- xxi. General cleaning of alternator with a hand blower once in every Quarter.
- xxii. Cleaning of radiator will be in the scope of Vendor. Should be maintained properly every month.
- xxiii. Maintenance of Engine Panel / PCC, Alternator will be covered in AMC.
- xxiv. The engine shall be run on load or at available load and should be checked for any leakage and abnormal noise. If any such abnormality shall be diagnosed and remedial action shall be taken.

## **B. Terms and Conditions of Non-comprehensive AMC:**

- i. Period of Contract will be 12 Months
- ii. 12 No's of Scheduled/Preventive Maintenance Visits i.e. 1 scheduled visit for every month during 01 year contract.
- iii. Scheduled Maintenance visit shall be performed within 1st week of every month.
- iv. Unlimited Breakdown calls as and when required without any extra cost.
- v. Engine major breakdowns, repair of fuel tank, Self Starter, Main alternator rewinding, Calibration of fuel pump is not in the scope of Vendor.
- vi. All Services offered under this contract shall be strictly in accordance with the engine & alternator manufacturer's standard service instructions.
- vii. Checklist as per the contract should be prepared and maintained by the successful vendor during the period of contract. Proper Check reports shall be submitted every month/every breakdown calls and duly acknowledged by the Incharge of Electrical maintenance.
- viii. All Tools, Testing Equipment, Multimeter, High Pressure Air Blower, High pressure water washer etc., needs to be carried by the Service Technician/Engineer of successful vendor with him at vendors own cost during site visit. No support will be provided by IGMH regarding provision of said Tools.
- ix. All consumable and spares, old cloth/ kerosene/ diesel/ cleaning liquid, if required will be provided by IGMH.
- x. AMC should include the guaranteed maximum of 4-hour on-site response, 6 days/week and 8 hours/day. i.e. If Generator gets breakdown, service engineer should be deputed at the site within 3 to 4 hrs.

### **3. Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

- i. For MSE/Start-up firm: The bidder must have capability to provide the relevant services. i.e. NC AMC of DG set(as mentioned in the Scope of Work). Bidders are requested to submit the documentary proofs like Purchase orders against their capability in providing similar services.
- ii. For other firm - Experience and past performance: The bidder should have experience of having successfully completed relevant services, in any one of the last five years ending on '31.03.2025'
- iii. Delivery Schedule: The duration of this contract will be One Year from date of issue of contract.
- iv. Payment Terms: Payment will be made on quarterly basis after successful and satisfactory execution of services of every Quarter and submission of Service reports/ breakdown reports along with the Hardcopy of Invoice.
- v. The bidder should submit duly stamped & signed copy of bid document as a token of acceptance of all the terms & conditions of the tender.

## **अस्वीकरण/Disclaimer**

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its

outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. 8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
