iv) **The spectrometer must be equipped with intuitive user interface that simplifies alloy identification.**

v) **The spectrometer must analyse hot samples up to 500 °C using proper hot heel faceplate.**

vi) **The spectrometer must have automatic eyelid shutter or any other suitable system that helps to prevent costly detector damage**

vii) **Memory & Data Handling:**

a) **The spectrometer must enable real-time data backups, downloads etc.**

b) **The spectrometer must be instantly exporting the analysis results through optional wireless connectivity, any suitable standard cloud system, or a USB flash drive.**
