Scope of work for pest control services:

1. Job of Mosquito control at Factory and Township:
Mosquito control treatment shall be carried on daily basis by using chemicals: Beta Cyfluthrin 2.4 % SC, Lambda Cyhalothrin 10% WP, Propoxure (20 % EC), Malathion (50 % EC)
2. Fogging of Mosquito control at Factory and Township: Mosquito control Fogging treatment is carried weekly Once a) Treatment by using chemicals: Deltamethrin 1.25% ULV, LPG Can, Diesel etc..
3. Job of Rodent control treatment at Factory and Township:
Rodent control treatment shall be carried on daily basis. The agency has to provide the below mentioned items every month:
 - a. Catch King Big (Glue pads)
 - b. Treatment with chemical # Bromadiolone 0.005 RB at open area.
 - c. Treatment using Zincphosphide / aluminium phosphide 56% tablets/Cakes/ glue traps at Borrows/Holes by fumigation.
4. Areas to be covered for treatment: Mosquito and rodent control activities will cover following areas:

5. Following work shall be carried out for above said work:

- 5.1 Environmental friendly Chemicals through permitted insecticides as per Government of India and WHO norms to be used which should not affect human and environment. All the chemicals should have the BIS marking and should bring in sealed conditions for use.
- 5.2 Use of chemicals that are harmless to humans and machines and treated area. MSDS report of these chemicals should also be attached. These chemicals, tools required for pest and rodent control and required man power is in the scope of bidder only. i.e. the bidder has to arrange these.
- 5.3 The bidder shall follow all plant safety rules and regulations, Security rules of India Government Mint, Hyderabad.
- 5.4 All necessary personal protective equipment to the workmen deployed for such activity for handling chemicals or pest including gloves (Heavy duty), Safety shoes, Uniform, face mask, Eye protection goggles, any other necessary items will be in the scope of vendor.
- 5.5 Registers should be maintained by the contractor for area wise pest control services with user department signatures.
- 5.6 List (Generic name, composition) and purpose of chemicals and equipment's used for pest control should be submitted. The chemicals should be stored properly and labelled as Bio hazard.
- 5.7 A good quality gum pads / metal cage traps for rodents at places / sites as and where required will be in the scope of vendor.
- 5.8 The bidder shall have valid License for providing Pest control and storing chemicals valid in Telangana state or Govt. of India and copies of valid licence should be submit along with the bid .
- 5.9 Safety and health of their staff/employees while working at I.G.Mint Hyderabad is responsibility of vendor.
6. Requirement of Manpower: The vendor shall provide services of 1 Skilled Manpower for Mosquito & Rodent Treatment work daily from Monday to Saturday excluding Sunday & Holidays Time 9.00am to 5.30 pm.
7. It is strongly advised for prospective bidders to visit the site of work area to get a thorough understanding of the scope and nature of work involved. No request for clarification on tender scope shall be entertained after opening of bids.

I. Eligibility Criteria:

1. For MSE/Start-up firm: The bidder must have capability to provide the relevant services.
2. For other firm - Experience and past performance: The bidder should have experience of

having successfully supplied relevant services of 40% of the tendered quantity, in any one of the last five years ending on '31.03.2025'

3. The bidder shall have valid license issued by Government of India or Government of Telangana for providing pest control services or pesticide license and shall upload along with the bid document.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
